Whereas the hon: Court of Probate for the District of New London did order & direct me David Adams of sd New London to sell dispose of so much of the real Estate of Samuel Adams of said New London deceas'd at public Auction as would raise the Sum of one hundred & sixty seven dollars & thirty one cents with the cost arising thereon, said cost estimated at the Sum of Nine Dollars and twenty five cents: - And whereas I the said David Adams did cause an advertisement to be inserted in the Connecticut Gazette No. 2158, 2159 & 2160 giving public notice that so much of sd Desc'd Real Estate situate in Groton in sd New London County as would be necessary for said purpose would be sold at the Dwelling House on the Premise on the 15th Day of April 1805 at which Time and Place I attended and struck off to Samuel Moxley of said Groton seventeen acres and one hundred & forty four Rods of land for the said sum being in the whole One hundred and seventy six Dollars and fifty six cents, he the said Samuel Moxley being the highest Bidder.-
